## Declaration of Conformity to EU RoHS

Products listed below that are manufactured by Gustav Klauke GmbH are in compliance with Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011 on the restriction of the use of certain hazardous substances in electrical and electronic equipment (also known as "RoHS Recast").
